Sustainable & Ethical Procurement Policy

1. Introduction

- Suppliers must ensure a long-term strategy for eradicating child labour in a manner that prioritizes the welfare of affected children.
- Children and young workers under 18 must not work at night, in hazardous conditions, or without appropriate supervision.

5.4 Right to a Living Wage

- Wages must meet or exceed national legal standards.
- Workers must receive written terms of employment outlining wage conditions before employment begins.
- Wage deductions as a disciplinary measure are strictly prohibited.

Suppliers are expected to:

- A confidential mechanism must be available for workers to report violations.

- Suppliers not meeting our standards must agree on an improvement plan.
- Plans will be tailored to individual cases and reviewed periodically.
- Connexion Developments Ltd reserves the right to terminate relationships with suppliers who fail to address serious breaches within
 agreed timelines.

7. Responsibilities & Authority

7.1 Company Leadership

This policy is issued under the authority of the Managing Director of Connexion Developments Ltd.

- Company Directors & General Manager are responsible for ensuring adherence to this policy within their respective divisions.
- Divisional Directors must implement and monitor compliance within their teams, reporting to their divisional boards.
- Managers are responsible for embedding this policy within their operations and reporting to directors.
- The Managing Director is responsible for reviewing the policy, ensuring it remains up to date, and overseeing training and guidance development.
